Good Governance Report

We continue on our good governance journey, making use of the <u>Play the Game Good Governance Observer Tool</u>. Through changes to the Memorandum and Articles of Association approved by the Members at the 2021 AGM and other internal procedural changes we have improved our score by 6% since last year.

Democracy, one of the core tenants Parkour Earth was founded on, continues to be our highest scoring area, but increases to our Accountability and especially Transparency scores were larger. Societal Responsibility remains 'not fulfilled' and is largely associated with our project output which will take the most effort and resources to develop.

Although our overall score remains low, we are still early in our organizational and good governance development and yet are already <u>ranking similar to well establishing International</u> Sports Federations studied in recent years.
